### **Required Applicant Qualifications:**

- Eligible for employment in the United States
- Graduate of an ACPE accredited Doctor of Pharmacy Degree Program
- Eligibility for State of Connecticut pharmacist licensure prior to beginning the residency
- Adhere to the rules of the Residency Matching Program
- Successful completion of a background check, pre-employment physical and drug screen (these will be scheduled after the match results)

- Values teamwork; able to work in multidisciplinary groups
